Continuing Education Article Vaccine Updates You May Have Missed During the Pandemic

The Public Readiness and Emergency Preparedness (PREP) Act Section 5 amendment specifically identified pharmacist and pharmacist interns as qualified persons to administer recommended vaccines to ages three years and older. There was no SARS-CoV-2 stipulation limiting this federal expanse in the scope of practice to this specific virus. In fact, the Texas State Board of Pharmacy appears to have embraced this broadening of the scope of practice and have thrust pharmacists squarely in the front lines in the fight against disease from SARS-CoV-2, also known as COVID-19. While COVID-19 is a current public health threat, we will not be reviewing the extensive and tumultuous COVID-19 data that will undoubtedly be outdated as soon as this is published. Instead, this continuing education update will review updates to other immunization schedules that may not have caught as much attention during the last year of COVID-19 vaccinations but are nevertheless important. As we approach respiratory virus season, we must encourage the public to stay up-to-date with their vaccinations; as practitioners, we must also stay up to date with the recommendations to best protect our communities.

The Advisory Committee on Immunization Practices (ACIP), the main regulatory body for vaccines, typically meets three times a year to review updates to vaccine safety and efficacy data.³ This year is a peculiar year for many reasons, including several emergency sessions held by ACIP. However, the next session to review non-COVID vaccines is not until October of 2021. ACIP has already made new recommendations on rabies vaccines, dengue vaccines, and influenza vaccines during this time. It has also reviewed the newly FDA-approved PCV-15 and PCV-20 with official recommendations expected during the October meeting...

Student Perspective Article Incorporating Geriatric Care into Rotations

You might be wondering why geriatrics? According to the CDC, in 2016 the number of adults 65 years and older was 49 million and accounted for 15% of the total population, however, the increase in the number of older adults is projected to reach 71 million of by year 2030 and 98 million by 2060. This would account for 25% of the entire United States population. Care for older adults is critical in the healthcare system as they are at an increased risk of chronic disease states such as dementia, diabetes, and heart disease which require lifelong pharmacotherapy. Pharmacists play a critical role in geriatric care due to the high requirement of prescription medications and the increased prevalence of polypharmacy within this population. This increase in the consumption of prescription medications puts these patients at a higher risk for medication errors, drug interactions, and adverse effects. Pharmacists help to reduce these risks of polypharmacy and to increase medication awareness by optimization of their pharmacotherapy.

Regardless of which pharmacy practice setting you work in unless it is primarily a pediatric setting, you will likely encounter geriatric patients. Therefore, it is imperative that pharmacy preceptors and their students work on strategies to enhance care for these patients. A few of these strategies are practicing effective communication, enhancing knowledge, and interpreting and performing clinical assessment of geriatric patients.

Effective Communication

Effective communication is important in establishing rapport with all patients, but there are a few important aspects to consider unique to geriatrics. For example, allow extra time for older adults to respond during interviews. Also, be cognizant of generational differences that can serve as barriers like language or jargon, technology, and using the proper form of formal address. It may be helpful to simplify and write down the instructions for older adults to ensure better understanding of the information that's delivered.

Enhancing Knowledge

Enhancing a student's knowledge on geriatrics during rotations is critical to ensure that they will be effective pharmacists to serve this patient subset. This can be accomplished by the utilization of the BEER's criteria² and STOPP/START³ while reviewing the patient's medications to allow for deprescribing of inappropriate, unsafe, or unnecessary medications.

Clinical Assessment

Lastly, learning how the clinical presentation of common disease states differ among geriatric patients compared to the rest of the population is critical for students. For example, urinary tract infections present with an atypical presentation in older adults like abdominal pain, incontinence, nausea or vomiting, and azotemia. Students need to be able to interpret and perform clinical assessment on geriatric patients and how it differs in comparison to the younger populations in order to provide them with adequate care.

Weaving geriatric components within a rotation is critical to the development of a future pharmacist since older adults account for a significant portion of the population requiring pharmaceutical care. The rising number of older adults demonstrates the increased demand for pharmacist involvement within geriatric care. Therefore, in order to prepare students for future success within the field of pharmacy they need to well verse with providing exemplary geriatric care in any setting.
