

2015-2016 UNTHSC Tuition and Fees

The information in this web site is provided to better assist students in assessing the cost of enrolling at the University of North Texas Health Science Center (UNTHSC). While this information is intended to be comprehensive, tuition and fees, are subject to increase or decrease by action of the Texas Legislature and/or the Board of Regents of UNT. Students are responsible for any additional amounts due UNTHSC resulting from post audits and corrections, including all fees and waivers; i.e. registration assessing errors, changing from off-campus to on-campus classes, invalid employment waivers, etc.

UNTHSC is a state-supported institution and, as such, is subject to state laws. Since state law prohibits the extension of credit, all financial obligations to the university must be made when due. The university cannot cash checks made payable to it and the student. Checks made payable to the university and the student can be applied to a student's account balance after obtaining the proper endorsement.

Tuition

Statutory Tuition (§54.051)

Statutory tuition rates are set by the Legislature. Tuition generated from statutory tuition must be deposited in the State Treasury and expenditures from these funds are subject to state expenditure guidelines.

Designated Tuition (§54.0513)

Designated tuition allows the institution to determine the rate per semester credit hour to be charged. Designated tuition is charged in addition to the statutory and board authorized tuition. Designated tuition must be used to support the academic mission of the institution but maintains more flexibility than statutory tuition. The Board of Regents must approve designated tuition rates.

Board Authorized Tuition (§54.008)

Board authorized tuition must be approved by the governing board of the institution. It cannot be higher than the statutory rate.

Excess Hours Tuition (§54.012)

Doctoral students who take more than 130 semester credit hours to complete their degree will be subject to out-of-state tuition rates.

Fees

Account Services Fee (§54.504)

A fee of \$25 per term is charged to each student enrolled at the UNT Health Science Center. This fee covers the costs associated with payment services.

Cadaver Anatomy Fee (§54.504)

A \$375 fee is collected for each DO and PA student during the first and second year of enrollment. DPT students are charged this same fee during the first year of enrollment only. This fee is also charged to GSBS Medical Sciences and Structural Anatomy students. This fee covers the costs associated with student activities that involve dissections and prosections.

Environmental Services Fee (§54.5041)

A fee of \$10 per term with an annual maximum of \$30 will be charged to all enrolled students. Medical students will be charged the annual maximum of \$30. This fee supports the costs associated with recycling and energy conservation efforts.

ID Card Fee (§54.504)

A \$25 ID card fee is collected from each student during his or her first term of enrollment. This fee covers the cost associated with issuing student identification cards. A replacement fee of \$25 is charged for misplaced or damaged cards.

Installment Fee (§54.007)

A fee of \$15 will be charged to all students electing to pay tuition and fees by installment.

International Student Service Fee (§54.504)

A fee of \$20 is collected each term from students that are not citizens or permanent residents of the United States. This fee covers costs associated with providing services unique to this student population. These services include orientation programs, personal counseling regarding immigration rules and visa status, and other related issues.

Instructional Fee – Academic Support Services (§54.504)

All courses utilizing Academic Support Services are subject to a fee of \$7.50 per semester credit hour. This instructional fee will support the academic support services provided for specific courses in which this service is utilized.

Instructional Fee – Assessment Services (§54.504)

This instructional fee will be charged to all pharmacy students in the fall semester. The fee will support the assessment services provided for specific courses in which this service is utilized. For specific amounts [click on this link](#)

Instructional Fee – Professional Development Services (§54.504)

A fee of \$55 will be charged in the fall semester to all pharmacy students. This instructional fee will support the professional development services provided for specific courses in which this service is utilized.

Instructional Fee – Library Services (§54.504)

All courses will be charged a fee of \$7.50 per semester credit hour instructional fee in the form of a library fee. This fee will support the services provided by the library.

Instructional Fee – Technology Services (§54.504)

All courses will be charged a fee of \$2.50 per semester credit hour instructional fee in the form of a technology fee. This fee will support the services provided by Academic Information Resources and Technology.

Instructional Fee – Testing Services (§54.504)

All courses that utilize testing and evaluation services will be charged up to a \$7.50 per credit hour instructional fee in the form of a testing and evaluation services fee. This fee will support the testing and evaluation services provided for specific courses in which this service is utilized.

Instructional Fee – Distance Learning (§54.504)

All courses offered in an online or distance learning format will be charged a fee of \$65 per semester credit hour. This instructional fee will support the needs related to the delivery of online courses.

Insurance Processing Fee (§54.504)

A fee of \$12.50 will be charged to all students that apply for a plan offered as part of the UNT System sponsored student health insurance plan. This fee may only be charged to a student once per academic year with an annual maximum of \$12.50. This fee supports the costs associated with the verification and processing of student health insurance plans.

Lab Coat Fee (§54.504)

A \$30 fee is collected for each student in any GSBS program during his or her first term of enrollment. This fee covers the costs associated with issuing lab coats.

Lab Fees (§54.501)

A fee of \$25 per year is collected from all first and second year medical students. First year physician assistant and physical therapy students are charged \$12.50 in the fall and spring term. A fee of \$12.50 is collected from all first and second year pharmacy students in the fall and spring term.

Late Registration Fee (§54.504)

A fee of \$25 is collected from all students registering during the designated late registration period.

Matriculation Fee (§54.504)

A \$50 fee is collected during the first term of enrollment for each new student.

Medical Services Fee (§54.5081)

The fixed medical services fee is used solely to provide medical services to students registered at the health science center. This fee is \$67 per term or \$200 per academic year.

Parking Fees (§54.505)

Student parking permits are \$90 per academic year. If the permit is lost, stolen, or destroyed, replacement permits will be issued at a charge of \$5.

Professional and General Liability Insurance Fee (§54.504)

All students are required to carry professional and general liability insurance. This fee is \$55 per academic year for medical and physician assistant students and \$13 per academic year for all other students.

Registration Reinstatement Fee (§54.504)

Students who fail to make payment of tuition and fees by the payment deadline will be administratively withdrawn. Registration may be reinstated upon appeal with a reinstatement fee of \$250.

Student Center Fee (§54.515)

A fee of \$10 per term or \$30 per academic year is collected from all students for the maintenance and operation of the student lounges.

Student Health Insurance Fee (§54.504)

Please review the Student Affairs Student Health Insurance website for program-specific student health insurance rates. It is compulsory for all students to carry medical and hospitalization insurance while enrolled at the Health Science Center. All students will be automatically enrolled and billed for the UNT System Student Health Insurance Policy. Students can waive this coverage by providing proof of coverage in the form of insurance documents showing minimum coverage amounts by the census date of each term of enrollment. Insurance coverage must remain in effect throughout the duration of enrollment. For waiver information, students should visit the Student Affairs website.

Student Services Fee (§54.503)

Student service fees are assessed to cover the costs of student services that directly involve or benefit students, including but not limited to, recreational activities, lecture series and student government. This fee is \$20 per semester credit hour with a minimum of \$120 and a maximum of \$250 in the fall, spring, and summer terms. Medical students are charged the annual maximum of \$750.

Transcript Fee (§54.504)

A \$50 fee is collected from each student during his or her first term of enrollment. This one-time fee allows each student to order an unlimited amount of UNTHSC Official Transcripts.

Technology Fee (\$54.504)

A \$2000 fee is collected for each DO, PA, DPT, PharmD, Medical Science, Biotechnology, Clinic Research Management, SPH MPH (excluding Professional Option), SPH DrPH, and SPH PhD student during their first term of enrollment. GSBS Forensic Genetics-MS students are charged \$1500 during their first term of enrollment. This fee covers the costs associated with issuing laptops to each student.

White Coat Ceremony Fee (\$54.504)

A \$100 fee is collected from each DO, PA, DPT, and PharmD student during their first term of enrollment. This fee covers the costs associated with the White Coat Ceremony and the issuing of a white coat to each student.

Student Payments

UNTHSC provides the following alternatives for the payment of tuition and fees during the fall and spring terms:

Students charged by semester credit hour

- Full payment of tuition and fees upon registration.
- Full payment by payment deadline.
- One-half payment of tuition and fees plus payment plan fee upon registration or by the payment deadline, with separate one-fourth payments prior to the start of the sixth and eleventh class weeks. The Student Health Insurance Fee is not included in the payment plan.

Tuition and fees must be paid in full for each summer term upon registration or by the payment deadline. Payment for any additional fees resulting from Schedule Revision or Add/Drops is due by the end of the Add/Drop period. Tuition payment by installment is not offered during the summer sessions.

Medical Students

- Payment Option 1: All tuition & fees are to be paid prior to the official first day of classes.
- Payment Option 2: Payment in two installments with the first installment due prior to the first day of classes and the second installment due prior to the first day of class in January. (Default plan). A \$15 payment fee will be added to the initial installment. Payment Option 3: Payment in four installments with the first installment due prior to the first day of classes, the second installment due in October, the third installment due prior to the first day of class in January, and the final installment due in March. Please see the Installment Plans on the Forms section within the [Student Finance website](#) for details.

All course-related and optional fees are paid with the initial installment payment including the non-refundable handling fee of \$15.00.

PLEASE NOTE:

By choosing the installment plan, a student recognizes they are in a contractual agreement. A student who fails to make payment of tuition and fees, including any incidental fees, by the due date, may be prohibited from registering for classes until full payment is made. A student who fails to make payment prior to the end of the term may be denied credit for the work done that term.

Tuition and Fee Refunds

A student who drops a course or withdraws from the university within a certain time period may be entitled to a partial refund of tuition and fees. These refunds are calculated according to the category and time schedule listed below. Delinquent payment fees, late registration charges, publication fees and installment handling fees are non-refundable. Any financial obligation to UNTHSC must be resolved before any refund is processed.

Class Drops

Refunds are made for any course dropped through the 12th class day for the fall or spring term or a summer session of 10 weeks or longer, within the first four class days of a term or session of more than 5 weeks but less than 10 weeks, and within the first 2 class days of a session 5 weeks or shorter. The term's first class day is always the first official university day of classes for that specific term or session and not the first day of an individual's class. To calculate the refund for a class dropped, take the fee paid for the original hours and subtract the fee shown within this Tuition and Fee site for the new number of hours. The difference between the two is the amount credited to the student account.

NOTE: If all classes for the semester are dropped, see the Withdrawal Refund schedule below.

Withdrawal from School

Withdrawal refunds are determined by the number of enrolled semester credit hours at the time of withdrawal. Withdrawal percentages are applied to the total amount of tuition and fees as prescribed by state law, NOT the amount paid. The withdrawal schedule and the percentage of refunds shown below pertain to total withdrawal from the term and are mandated by the state legislature. The term's first class day is always the first official university day of classes for that specific term or session and not the first day of an individual's class. A withdrawal refund is based on the day of withdrawal, regardless of the date the class first meets.

Tuition and Fee Waivers

Several exemptions and waivers are available to qualifying students. Brief descriptions of these are listed below. Waiver refunds must be requested during the the term application is made. Such requests must be made before before the census date for all terms. Requests for retroactive refunds cannot be honored.

Exemptions and Waivers

1. Certain Texas veterans and dependents of deceased Texas veterans of the Armed Forces of the United States are exempted from payment of tuition. State application and other documents required. This exemption pays all tuition and fees except for the Student Service Fee and Property Deposit. The student must pay the Student Service Fee each term/semester.
2. Certain orphans of members of the Armed Forces, Texas National Guard and Texas Air National Guard are exempted from payment of tuition. Documentation required. This exemption pays all tuition and fees.
3. Certain students from other nations of the American hemisphere are exempted from payment of tuition.
4. Deaf or blind Texas residents are exempted from payment of tuition. Official letter required. This exemption pays all tuition and fees.
5. Certain disabled peace officers are exempted from payment of tuition and fees. Official letter required. This exemption pays all tuition and fees.
6. Children of disabled or deceased firemen, peace officers, employees of the Texas Department of Corrections and game wardens are exempted from the payment of tuition. Official letter required. This exemption pays all tuition and fees.
7. Children of U.S. prisoners of war or persons missing in action are granted exemption of tuition. Documentation required. This exemption pays all tuition and fees.
8. Resident rather than non-resident tuition is applied to out-of-state students enrolled through the Academic Common Market Program. This waiver waives out-of-state tuition. The student pays in-state tuition rates.
9. Resident rather than non-resident tuition is applied to U.S. military personnel, their spouses and dependents if they meet designated criteria. (Certificate must be approved by the Registrar prior to registration.) Form submitted by the Registrar's office. This waiver waives out-of-state tuition. The student pays in-state tuition rates.
10. Resident rather than non-resident tuition is applied to teachers and professors of Texas state institutions of higher education, their spouses and children. Requires official application approved by hiring department. This waiver waives out-of-state tuition. The student pays in-state tuition rates.
11. Resident rather than non-resident tuition is applied to a teaching or research assistant provided the student is employed at least one-half time by UNTHSC in a position that relates to the degree sought. Requires official application approved by hiring department. This waiver waives out-of-state tuition. The student pays in-state tuition rates.
12. Resident rather than non-resident tuition is applied to a non-resident holding a Health Science Center competitive academic scholarship of at least \$1,000.00 for the academic

year or summer for which the student is enrolled. Requires official approval from the University of North Texas Health Science Center's Institutional Scholarship Committee. This waiver waives out-of-state tuition. The student pays in-state tuition rates for terms stated in award notice.

13. Students who are concurrently enrolled in more than one program at the Health Science Center are not charged duplicate fees.
14. Certain Health Science Center fees are waived for students enrolled only in off-campus courses.
