

# COVID-19 / Coronavirus Considerations for Animal Research

*UNTHSC guidance for UNTHSC investigators in regards to recent events concerning COVID-19.*

**What do I need to know about conducting animal research that is currently approved by the UNTHSC IACUC?**

As referenced in the guidance issued by the UNTHSC Vice President for Research on March 17, 2020:

- *Individual IACUC-approved research activities with animals may continue while the University remains open with limited operating personnel.*
- *The Department of Laboratory Animal Medicine (DLAM) has standard emergency operating procedures that will be implemented as needed.*
- *If DLAM personnel are personally impacted by this situation, it may limit access to the DLAM facilities. If this happens, you will receive additional information from DLAM.*

In addition, the following is general guidance about research activity:

- All researchers should consider the impact of their research activity on the health and safety of themselves and others.
- Tarrant County has issued a Shelter in Place notice. Please contact your respective Dean to request access to the campus for administering care for your animals.
- Individual investigators should develop their own contingency and research continuity plans, especially for specialty irreplaceable animals, or animals on chronic studies. Please note that compliance must be upheld while making contingency and research continuity plans.
- Please be respectful towards DLAM Staff, as the care and welfare of the animals is of great importance.

### **What if my protocol renewal is due?**

Please be sure to submit renewals at the appropriate times to avoid disruption in the study. Please note that if a protocol expires, animals will immediately be placed on a holding protocol in which no animal work may occur, until the renewal protocol is approved.
