There will be a total of 8 request for proposals (RFP) in calendar year 2018 – 4 programs run for two cycles each. A new RFP will open at the first of every month except July and December. The programs expect to fund up to 21 projects with a total of \$500,000. The four programs are:

- Basic Research: RFP's open **March 1 and August 1**
- Applied Research: RFP's open **April 2 & September 4**
- SBIR Phase 0: RFP's open **April 30 & October 1**
- Digital Health Program: RFP's open **June 1 & November 1**
